This is a summary of the annual report of the Emeritus Institute of Management, Inc Health & Welfare Plan, EIN 83-1356339, Plan No. 501, for period 01/01/2025 through 12/31/2025. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Emeritus Institute of Management, Inc. has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Ameritas Life Insurance Corp, Healthjoy, Cigna Health and Life Insurance Company, and Life Insurance Company of North America to pay Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, Hospital, Telehealth, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2025 were \$169,714.
